Brief description of the Host organisation:	Cymru Wledig LPIP Rural Wales is an initiative funded by UKRI to facilitate knowledge exchange between academic research and policy development and implementation relating to Rural Wales. Our work involves (1) Strengthening the evidence base for policy, through short, targeted, research projects; surveys; data integration and analysis; and knowledge brokering; (2) Finding solutions to policy challenges through Innovation Labs, Dialogues, and Equalities Mainstreaming; (3) Empowering communities to understand and address local issues, through Community-led Action Research and training and capacity building. Our work programme is responsive to the research and innovation needs identified by our partners and stakeholders, within the broad themes of 'Building a Regenerative Economy', 'Empowering Communities for Cultural Resilience', 'Enhancing Wellbeing in Place' and 'Supporting the Net Zero Transition'. The activities are undertaken by a team of academics, research staff, support staff and other experts located across the partnership, which includes Aberystwyth, Bangor and Cardiff Universities, the Countryside and Community Research Institute, and

	several social enterprises, businesses and third sector organisations, most substantially, the Centre for Alternative Technology and Together for Change.

Placement role title: e.g <i>Policy officer</i>	Graduate Researcher
Background/expected impact of the project:	<p>As described above, the Cymru Wledig LPIP Rural Wales work programme involves a range of activities across a variety of topics. Six targeted research studies have been complete on growth in the rural economy; women and farm diversification; multi-solving from net zero initiatives; food and community wellbeing; Wales's intangible rural cultural heritage; and the use, management and potential of community spaces. Four innovation labs have explored solutions to challenges around developing low carbon horticulture; recruitment to the construction industry; community food projects; and the Welsh language and grassroots sport. Five community-led action research projects have been completed, with six further projects underway, on topics ranging from community transport to water quality. An equalities mainstreaming panel is investigating public transport; and surveys have been completed on community resilience and on rural crime, with a rural business survey in progress.</p> <p>For the RinP placement, you will primarily work on a discrete project that synergises findings and lessons from across all of the Cymru Wledig LPIP Rural Wales projects and activities around a specific cross-cutting theme. It will involve reviewing data collected through these projects and activities; talking to Cymru Wledig LPIP Rural Wales researchers and partners; and potentially following-up specific issues through additional data collection and analysis.</p>



	<p>Up to four cross-cutting projects will run in parallel. Each RinP placement student will be responsible for leading a project but there will be opportunities to collaborate with other RinP placement students in delivering the work. The four projects are:</p> <p>Project 1: Insights for Wellbeing Plans. How does evidence collected by Cymru Wledig LPIP Rural Wales relate to the seven Wellbeing Goals? How might insights be incorporated into Local Wellbeing Plans and the work of Corporate Joint Committees?</p> <p>Project 2: Rural Data. What does work by Cymru Wledig LPIP Rural Wales reveal about the coverage and appropriateness of statistical data relating to rural Wales and its utility for policy-making? What gaps in data coverage have been identified? Can proposals be elaborated for new indicators and/or methodologies?</p> <p>Project 3: Inclusion and Exclusion. What insights are provided by Cymru Wledig LPIP Rural Wales research and innovation activities into experiences of inclusion and exclusion by different groups in rural Wales, including around age, gender, sexuality, ethnicity, language, or physical and mental ability and health. Have specific challenges or instances of exclusion been identified? Have any examples of good practice to promote inclusion been recorded?</p> <p>Project 4: Co-production and Participation. What does the evidence collected by Cymru Wledig LPIP Rural Wales tell us about process of co-production and participation in research and policy in rural Wales? This includes co-design and participation in research, among communities and stakeholders, including perspectives on research, and co-production of policy and rural development projects. What barriers have been observed and have any examples of good practice been documented?</p> <p>You will be asked to indicate your preference for the above the projects, in ranked order, when applying.</p>

	<p>We are also open to considering student-led proposals for other placement projects that fit with the Cymru Wledig LPIP Rural Wales themes and objectives as well as the objectives and rules of the RinP scheme.</p> <p>The outcomes from these projects will inform recommendations from Cymru Wledig LPIP Rural Wales to Welsh Government, the Office of the Future Generations Commissioner, local authorities, joint corporate committees, and other relevant bodies for changes to policies and procedures. They will also be used in the evaluation of the Cymru Wledig LPIP Rural Wales programme and critical reflection on its experimental methodologies.</p>
Outline of duties/description of opportunity	<p>You will primarily work on your specified project, in which you will be responsible for data collection, data analysis, report writing, and preparation of materials for policy engagement, working alongside a Cymru Wledig LPIP Rural Wales co-investigator and/or post-doctoral researcher.</p> <p>In addition to this primary focus, you will also have the opportunity to contribute to at least one other research or innovation activity within the Cymru Wledig LPIP Rural Wales work programme. Depending on your interests and the timing and location of the placement, this could involve supporting community-led action research; monitoring and evaluation of a test innovation to overcome obstacles to a defined change; survey construction and/or analysis; collation, manipulation, analysis and/or mapping of secondary data; or supporting citizen assembly-type Dialogues on key policy issues. You will additionally contribute to at least one public- or policy-engagement activity, including planning, preparation of materials, and on-day support</p>
Expected output(s)/deliverable(s)	From the main project: a short report and a policy briefing, including recommendations. You will also be asked to write a blog post for the Cymru Wledig LPIP Rural Wales website about your work with us.

Recruitment process	<p>Cymru Wledig LPIP Rural Wales is responsible for processing the applications received for this opportunity and applications will be processed as follows:</p> <ol style="list-style-type: none"> 1. All applications will be reviewed by the members of the Cymru Wledig LPIP Executive Committee. This includes a Co-Director from each of the four partner universities and from two non-university partners, Together for Change and Sgema. 2. If necessary (due to application numbers), Exec members will score applications and shortlist applicants on the following criteria: <ul style="list-style-type: none"> • Relevance of academic training and experience. • Fit of skills to the specified activities. • Evidence of capacity to work effectively as part of a team.

	<ul style="list-style-type: none"> • Capacity to undertake the work through the medium of Welsh. <p>3. Shortlisted applicants will be interviewed by a panel drawn from the Cymru Wledig LPIP Rural Wales. Applicants will be ranked and placements offered on the basis of their application (CV and cover letter) and interview, assessed on the above criteria plus:</p> <ul style="list-style-type: none"> • Understanding of the research and policy context of Rural Wales • Understanding of the principles of policy engagement • Clarity and significance of anticipated benefits for professional development and career opportunities • Evidence of inter-personal skills to support engagement with colleagues and wide range of audiences. <p>4. Top ranked candidates will be matched to projects according to their preferences. You may be offered a project other than your first preference if this has been matched to a higher ranked candidate.</p>
